The advanced tour programme (ATP) of MVUs for 3rd quarter of 2020-21 (October - 2020 to December-2020) of your block submitted by you has been approved by the undersigned (copy enclosed). In addition, due care should be taken while performing the tours so that the fuel charges should never go beyond the maximum limit of Rs.8000/- in a month.

Further, the concerned villagers and local Sarpanch/^{PRI members} should be informed well in advance for effective organization of the animal health camps. The local para veterinarians should also be informed to attend the camps on schedule date to assist in vaccination and treatment of animals.
