2. Payment shall be made on production of bills on each tour basis at the end of each month basing on the Kms. covered and halting charges or on daily basis for short tours and payment will be made availability funds/allotment.
3. The vehicles should be provided on any day including Sunday and holidays, as and when required in the schedule time on intimation over phone / written order.
4. The approved rate shall remain valid up to one year from issue of the acceptance order without any revision in it within the year.
