Livelihood support to farmers through Duckery farming under 'State Plan' during the year 2023-24 for convergence with farm pond plus scheme

Introduction

Odisha being an agrarian state, majority of farming households undertake livestock rearing for augmenting their incomes. In Odisha, duck rearing is popular especially among small, marginal and landless labourers. Duck rearing is profitable and simple to manage since these birds are disease resistant, have longer economic egg-production life and do not need elaborate housing. Improved varieties of layer ducks like Khaki Campbell and Indian Runner, meat varieties like White Pekin and Muscovy and other approved breeds have its own merit because of their egg production capacity and meat quality.

Layer ducks have high egg laying capacity (up to 250 eggs per year) and meat purpose ducks can achieve a body weight of 2-2.4 kg in 6 weeks of age. Under the scheme, each household will be provided with 50 unsexed 2 weeks old ducklings which will promote integrated farming, thereby augmenting incomes of farmers and also provide additional nutritional security at household level.

Aim & Objective

The project intends to

- Increase egg and meat productivity in the state.
- Promote duck rearing and enhance incomes of SC/ST/Women/Transgender/
 Differently Able (Min 40% disability) / Poor farmers in the state, in convergence with the Farmpond Plus scheme.

Target

2000 nos. of SC/ST/Women/Transgender/ Differently Able (Min 40% disability) / Poor farmers in the State in convergence with the Farm pond Plus scheme to rear 50 nos. of 02 weeks old unsexed Ducklings. Community level volunteers like Prani Mitras /Gomitras will be roped in for vaccinating the ducks reared in the backyards.

Selection of Farmers

- i. SC/ST/Women/Transgender/ Differently Able (Min 40% disability) / Poor farmers will be selected under the programme.
- ii. The certificate of identity as transgender persons issued by District Magistrate as per 'The Transgender Persons (Protection of Rights) Act, 2019" will be accepted for Transgender category.

- iii. For differently able persons the certificate if disability issued by certifying authority / competent authority indicating 40% or more disability as per "The Rights of Persons with Disability Acts, 2016" will be accepted.
- iv. While availing subsidy, beneficiary family will be considered instead of individual member of family. One beneficiary family should not be provided with multiple benefits under one particular scheme. A family will not be eligible for subsidy under the same scheme if any of its members has got subsidy during last three years.
 - v. The District wise indicative target of beneficiaries to be covered is shown at

 Annexure I. The Director AH&VS may revise the district wise target as per the

 demand.
 - vi. The name of the beneficiaries having farm pond scheme will be collected from concerned District Soil conservation and water shed Department. And the same will be countersigned by the concerned BVO, LI, and the PRI Members and submitted to CDVOs for approval.
 - vii. The database of the beneficiaries covered under the scheme shall be Aadhaar linked to prevent duplication.
 - viii. Block wise training of the beneficiaries shall be organized by the BVO. 50 farmers in a batch will receive training on recommended management practices including feeding and watering, brooding and rearing ducklings out of the IEC funds.
 - ix. The Pranimitras/ Gomitras will be oriented at block Head Quarter by AVAS/BVO regarding recommended management practices in backyard poultry. They will be roped in to guide the farmers in field for managing backyard duckery units.
 - x. Small-scale duckery units will be managed by the households using family labour.
 - xi. A Night Shelter will be constructed before receiving ducklings by the beneficiaries using locally available materials with minimum expense of Rs 1000/-by the beneficiary (with 100% subsidy). The assistance of Rs 1000 will be provided to each farmer for construction of a night shelter through DBT.
 - xii. The farmers will arrange feed for ducklings during the early stage as per the availability of local ingredients. The birds will be reared in free range system with little hand-feeding especially kitchen-wastes.
 - xiii. 50 numbers of two weeks old unsexed ducklings will be distributed to each farmer in convergence with the Farmpond Plus scheme in two phases (25+25) with a gap of 2 months.

- xiv. The cost of 1st phase of ducklings amounting to Rs 1500 will be provided to farmer for procurement of 25 numbers of two weeks old unsexed ducklings. Then after a gap of 2 months the cost 2nd phase duckling amounting to Rs 1500 will be provided to farmer for procurement of 25 numbers of two weeks old unsexed ducklings.
- xv. Geo-tagged photographs of each backyard duckery unit should be recorded.
- xvi. Timely disease prevention measures through routine vaccination & other health care programmes will be taken up to minimise occurrence of diseases & thus preventing mortality of birds.
- xvii. Quality checking of ducklings procured by the beneficiaries shall be ensured by concerned BVOs.
 - xviii. All data with regard to the scheme should be entered online on the DSS portal at Block and district level.
 - xix. The daily progress report will be uploaded in the online DSS portal by CDVO.
 - **xx.** Administrative Cost will be given to CDVOs to meet the expenditure incurred towards monitoring & supervision of the scheme.
 - **xxi.** The block wise final list of the beneficiaries will be uploaded in the directorate website.
 - xxii. Subsidy will be released to the beneficiaries in their bank account through DBT mode only.

Supply Chain

The ducklings will be purchased by respective farmers from Govt Duck Breeding Farms or any reputed source. The CDVOs will facilitate for procurement of ducklings by the farmers.

Monitoring

Regular monitoring will be done by the SDVO Concern along with ADVO LP under the direct supervision of the CDVO. The Directorate of AH & VS will coordinate and monitor the progress of implementation of the scheme every fortnight.

Scheme outlay:

The unit cost of one backyard Duckery unit consisting of 50 numbers of two weeks old unsexed ducklings is Rs 4000.00. The total expenditure under state plan to supply

2000 SC/ST/ Women/Transgender/ Differently Able (Min 40% disability) / Poor farmers in the State in convergence with the Farm pond Plus scheme is **Rs. 80.20 lakh** (including the Admin cost @ 0.25% of total cost).
