The advanced tour programme (ATP) of MVUs for 3rd quarter of 2023-2024 (October to December) of your block submitted by you has been approved by the undersigned (copy enclosed). You are therefore requested to stick to the ATP without any deviation in order to maintain regularity as per the schedule. If at all any deviation or changes from approved tour programme occur in exigencies, it should be intimated to the undersigned well ahead or within 3 days for post facto approval so as to avoid any problems in future or else the payment will be made as per the kilometres and dates approved in Advance Tour Programme. In addition, due care should be taken while performing the tours so that the fuel charges should never go beyond the maximum limit of Rs.11,500 /- in a month.

Further, the concerned villagers and local Sarpanch should be informed well in advance for effective organization of the animal health camps. The local para veterinarians should also be informed to attend the camps on schedule date to assist in vaccination and treatment of animals.
