Scheme: Support to Farmers for Establishment of Semi-Commercial Pig Farming in Individual Mode during the year 2022-23 to 2024-25 (OMBADC)

AIM:

The aim of the scheme is to support 200 nos. of small entrepreneurs for setting up of pig farms with a capacity of 5 female + 1 male pigs male goats for income generation (Total 90 No's of farmers for 3 years i.e 2022-23 to 2024-25).

SCHEME OBJECTIVE:

- To create small mother units with 5 sows and 1 boar at individual level..
- To support the nutritional requirement of the people through consumption of animal protein.
- To build the capacity of the farmers for undertaking pig farming as a profitable mini-enterprise
- To create employment as well as enhance supplementary income for farmers in rural areas

SCHEME OUTLAY & SUBSIDY:

- Unit cost of (10+1) pig farm under the Scheme is Rs. 2,10,000/-
- Subsidy amount @ 100% of the unit cost **amounts to Rs.2,10,000/- (Back Ended** to the very poor mining affected individual of the community.

ELIGIBILITY:

FINANCIAL ASSISTANCE THROUGH DBT:

Rs. 2,10,000/- as back ended subsidy per very poor mining affected individual

- ❖ Ph-I (20% of Rs. 2,10,000/- i.e. Rs. 42,000/-) after completion up to lintel level of Pig shed (Sty).
- ❖ Ph-II (20% of Rs. 2,10,000/- i.e. Rs. 42,000/-) after completion along with Electrification of Pig shed (Sty).
- ❖ Ph-III (60% of Rs. 2,10,000/- i.e. Rs. 1,23,150/-) after stocking of animals (5 Sows & 1 Boar).

(Rs. 2,850/-) towards cost of Insurance of 6 no's of Pig Units.

SUPPORT FROM THE DEPARTMENT:

1. Training will be organized at regional level or any other convenient place after final approval of the list..
2. The skill up-gradation training for individual will be arranged along with visit to a nearest pig farm under ongoing farmer capacity building program.
3. Individual will be trained on recommended management practices on feeding, breeding, preventive health care, record keeping, etc.
4. The concerned Livestock Inspectors, Gomitras and PraniMitras will have to guide the farmers in field for managing the pig units..
5. The capacity building of LIs, Gomitras, PraniMitras will be taken up by the Dept.

DOCUMENTS REQUIRED:

1. Identification proof (Aadhaar card)
2. Land document/lease deed (Photocopy)
3. 40%/50% of project cost to be – Self financed / Bank loan
4. If bank loan consent letter from bank
5. Bank A/C no. with IFSC code for DBT (Photocopy)
6. Self-declaration with form/Application Form.

PROCESS FOR PROVIDING SUBSIDY:

1. Online application in the **GO Sugam** Portal (<https://sugam.odisha.gov.in>)
2. BVO checks document, upload photographs and submit verification report to CDVO
3. Approval by district CDVO and issue of Go-ahead post approval of DLC

4. Physical verification of the completion of Sty by Block Inspection Team(BIT)
5. Release of first installment through DBT
6. Physical verification of partially animal induction by Block Inspection Team(BIT)
7. Release of second installment through DBT
8. Physical verification of fully animal induction by Block Inspection Team(BIT) completed project & its management by BVO/SDVO/ADVO.
9. Release of final installment through DBT
