**Scheme: Support to Farmers for Establishment of Small Scale Goat Farming in Individual Mode during the year 2022-23 to 2024-25 (OMBADC)**

**AIM:**

The aim of the scheme is to support 336 nos. of small entrepreneurs for setting up of goat farms with a capacity of 10 female + 1 male goats for income generation (Total 1002 No's of farmers for 3 years i.e 2022-23 to 2024-25).

**SCHEME OBJECTIVE:**

- To create small mother units with 10 does and 1 buck at Beneficiary level.
- To support the nutritional requirement of the people through consumption of animal protein.
- To provide livelihood support to the interested small, marginal farmers and landless labours.
- To create employment as well as enhance supplementary income for farmers in rural areas

**SCHEME OUTLAY & SUBSIDY:**

- Unit cost of (10+1) goat farm under the Scheme is Rs. 1,02,000/-
- Subsidy amount @ 100% of the total unit cost i.e Rs. 1,02,000/- (Back Ended) to the very poor mining affected individual of the community.

**ELIGIBILITY:**

- The very poor mining affected Individuals of the community.

### FINANCIAL ASSISTANCE THROUGH DBT:

**Rs. 1,02,000/- as back ended subsidy per very poor mining affected individual**

- ❖ Ph-I (30% of Rs. 1,02,000/- i.e. Rs. 36,000/-) after completion of goat shed.
- ❖ Ph-II (30% of Rs. 1,02,000/- i.e. Rs. 36,200/-) after partially stocking of animals (5 Female & 1 Male kids).
- ❖ Ph-III (25% of Rs. 1,02,000/- i.e. Rs. 25,000/-) after rest stocking of animals (5 Female kids).

Ph-IV (Rs. 4,200/-) towards cost of Insurance of 11 no's of goats Units.

### SUPPORT FROM THE DEPARTMENT:

1. Training will be organized at regional level or any other convenient place after final of approved list.
2. The skill up-gradation training for beneficiary will be arranged along with visit to a nearest goat farm under capacity building programme.
3. Beneficiary will be trained on recommended management practices on feeding, breeding, preventive health care, record keeping, etc.
4. The concerned Livestock Inspectors, Gomitras and Pranimitras will have to guide the

farmers in field for managing the Goat units.

5. The capacity building of LIs, Gomitras, Pranimitras will be taken up by the ARD Dept.

#### DOCUMENTS REQUIRED:

1. Identification proof (Aadhar card)
2. Land document/lease deed (Photocopy)
3. If bank loan consent letter from bank
4. Bank A/C no. with IFSC code for DBT (Photocopy)
5. Self-declaration form/Application Form.

#### PROCESS FOR PROVIDING SUBSIDY:

1. Online application in the **GO Sugam** Portal (<https://sugam.odisha.gov.in> )
2. BVO checks document, upload photographs and submit verification report to CDVO
3. Approval by district CDVO and issue of Go-ahead post approval of DLC
4. Physical verification of the completion of Goat shed by Block Inspection Team(BIT)
5. Release of first installment through DBT
6. Physical verification of partially animal induction by Block Inspection Team(BIT)
7. Release of second installment through DBT
8. Physical verification of fully animal induction by Block Inspection Team(BIT) completed project & its management by BVO/SDVO/ADVO.
9. Release of final installment through DBT
