In inviting a reference to the subject cited above, I am to state that the approved guidelines of the State Plan Scheme "Support to Private Goshala under Mukhyamantri Prani Kalyan Yojana (MPKY), 2026-27" have already been communicated separately to your office for necessary action.

The scheme envisages extending financial assistance to eligible private Goshalas for feeding, management and healthcare of stray, abandoned, infirm and old cattle with the objective of strengthening animal welfare measures and addressing the issue of stray cattle in the State.

In order to ensure smooth, transparent and time-bound implementation of the scheme, the following schedule of activities shall be adhered to **strictly without fail**..

You are, therefore, requested to take immediate steps for wide dissemination of the scheme guidelines among all eligible registered Goshalas under your jurisdiction and ensure strict

adherence to the prescribed timelines without any deviation.

It may further be ensured that scrutiny of applications and field verification are undertaken simultaneously with due diligence and transparency to avoid any delay in submission of the recommendations of the District Level Committee within the stipulated timeframe.

This matter may be accorded **top priority** for successful implementation of the scheme.

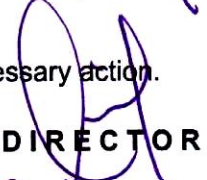
